Call for presentation of applications for assignment of no. 14 PhD scholarships, by evaluation of project proposals, only for candidates eligible who are not already recipients of D.M. 351/2022 or D.M. 352/2022 Scholarships in the merit rankings relating to the Call for admission to the PhD courses activated at the University of Messina - XXXVIII CYCLE - referred to in D.R. No. 1741 of 27th June 2022

THE RECTOR

- IN VIEW OF the Law of 3rd July 1998, No. 210, and in particular art. 4 in the matter of PhD course, as amended by art. 19, paragraph 1, of the Law of 30th December 2010, No. 240;
- IN VIEW OF the Statute of the University, issued with D.R. No. 1244 of 14th May 2012 (published on G.U. - General Series No. 116 of 19th May 2012) and amended with D.R. No. 3429 of 30th December 2014 (published on G.U. - General Series No. 8 of 12th January 2015);
- IN VIEW OF D.M. No. 226 of 14th December 2021 concerning *"Regulation laying down procedures for the accreditation of PhD centers and PhD courses and criteria for the establishment of PhD courses by accredited bodies"*;
- IN VIEW OF *the Regulation of the University of Messina concerning the PhD courses*, issued with D.R. No. 834 of 25th March 2022;
- IN VIEW OF D.M. No. 301 of 22nd March 2022 with which the *"Guidelines for the accreditation of PhD courses"* were approved (Ministerial Note No. 8424 of 23rd March 2022, prot. No. 38641 of 24th March 2022) and D.M. No. 289 of 25th March 2021, with which the "General guidelines of the programming of the Universities 2021-2023 and indicators for the evaluation of the results" were defined;
- IN VIEW OF D.M. No. 351 of 9th April 2022, with which some PhD scholarships, under the PNRR, Mission 4, component 1 "Enhancement of the provision of education services: from kindergarten to University" – Investment 3.4 "Teaching and advanced academic skills" and Investment 4.1 "Increase in the number of PhD courses and innovative PhD courses for public administration and cultural heritage", for the attendance of specific PhD courses, were assigned to the University of Messina by the MUR;
- IN VIEW OF D.M. No. 352 of 9th April 2022, with which a PNRR effective financial envelope, aimed at co-financing 50% of PhD scholarships for three years for the attendance of courses for innovative PhD courses accredited according to D.M. No. 45/2013 XXXVII cycle – A.Y. 2021/2022 and according to D.M. No. 226/2021 XXXVIII cycle – A.Y. 2022/2023, was assigned to the University of Messina by the MUR;
- IN VIEW OF the letters of intent and agreements with Universities and public or private research Bodies and Italian and foreign Companies for the activation and/or financing of PhD courses for the XXXVIII cycle;
- IN VIEW OF the resolutions of the Academic Senate, prot. no. 69064 of 30th May 2022, and the Board of Directors, prot. no. 69066 of 30th May 2022, with which, for the 38th cycle: the proposals for renewal, new activation, and participation in PhD courses in a partnership or in PhD courses of national interest and the allocation of positions, once evaluated the consistency with the objectives of the PNRR, were approved, as well as, with regard to no. 15 PhD courses based



	at the University of Messina, the start of the selection procedures, by qualifications and examinations, for admission to the PhD courses of the 38 th cycle, was established;
IN VIEW OF	the PhD Programmes approved by the PhD Academic Board of each PhD course recipient of scholarships according to D.M. No. 351/2022, subject to evaluation of consistency with the criteria referred to respectively in articles 7, 8, and 9 of the aforementioned decree;
IN VIEW OF	the Training Projects agreed with the companies and approved by the PhD Academic Board of each PhD course recipient of scholarships according to D.M. No. 352/2022, subject to evaluation of consistency with the criteria referred to in art. 6 of the aforementioned decree;
IN VIEW OF	D.R. No. 1741 of 27 th June 2022 (prot. no. 82863 of 27 th June 2022), with which the public competition, by qualifications and examinations, for admission to no. 15 PhD Courses, activated by the University of Messina – 38 th cycle was launched and the subsequent DD.RR. rep. no. from 2457 to 2470 and 2472 of 23 rd September 2022, with which the competition proceedings were approved and the merit rankings and admissions to the 15 PhD Courses available with the PhD call referred to in D.R. No. 1741/2022 were published;
GIVEN THAT	following the fulfilment of the competition, no. 5 scholarships relating to D.M. No. 351/2022 and D.M. No. 352/2022 were not assigned, in particular: 1. Position with scholarship D.M. 352/2022 M4.C2.I 3.3 co-funded at 50% by the company Fire S.p.A. for the PhD Course in “Industrial and Information Engineering”; 2. Position with scholarship D.M. 351/2022 M4 C1 I 4.1 PhD Courses for Public Administration, from the University of Palermo, for the PhD Course in “Mathematics and Computational Sciences”; 3. Position with scholarship D.M. 352/2022 M4.C2.I 3.3 co-funded at 50% by the company Deltacom S.r.l., for the PhD Course in “Mathematics and Computational Sciences”; 4. Position with scholarship D.M. 352/2022 M4.C2.I 3.3 co-funded at 50% by the company Ieeng Solution S.r.l. for the PhD Course in “Cognitive Sciences”; 5. Position with scholarship D.M. 352/2022 M4.C2.I 3.3 co-funded at 50% by Casa di Cura C.O.T. S.p.A., for the PhD Course in “Translational Molecular Medicine and Surgery”;
IN VIEW OF	D.M. No. 925 of 29 th July 2022 with which MUR reopened the deadline for presentation of additional proposals for the accreditation of the PhD Courses for the 38 th cycle and use of the scholarships under DD.MM. No. 351 and 352 of 9 th April 2022;
NOTED THAT	in the light of the new deadlines provided for by D.M. No. 925/2022, the University of Messina has reopened the deadline for the Call for Declaration of interest, addressed to companies as partners in innovative PhD Courses available to co-fund at 50% the PhD scholarships co-funded by D.M. 352/2022, so that additional proposals for PhD Courses able to meet research and innovation requirements of the companies on topics consistent with the PNRR could be made;
NOTED THAT	within the new deadlines provided for by D.M. No. 925/2022 the University signed no. 8 additional agreements , each of them to co-fund no.1 scholarship at 50% for the 38 th cycle under D.M. 352/2022 and in particular: 1. with the company Eni S.p.A. for the co-financing of the PhD Course in “Physics”; 2. with the company The Company Casale SA for the co-financing



of the PhD Course in “Advanced Catalytic Processes for Using Renewable Energy Sources (ACCESS)”;

3. with Farmacia Marra for the co-financing of the PhD Course in “Applied Biology and Experimental Medicine”, curriculum no.3 “Pharmacological Sciences”;

4. with the company Micerium S.p.A. for the co-financing of the PhD Course in “Bioengineering Applied to Medical Sciences”;

5. with the company Regedent Italia S.r.l. for the co-financing of the PhD Course in “Bioengineering Applied to Medical Sciences”;

6. with the company SA Fire Protection S.r.l., for the co-financing of the PhD Course in “Industrial and Information Engineering”;

7. with Clinica Veterinaria Camagna S.r.l. Gruppo VetPartners for the co-financing of the PhD Course in “Veterinary Sciences”;

8. with Istituto di Neuroscienze “Prof. Rocco A. Zoccali” for the co-financing of the PhD Course in “Translational Molecular Medicine and Surgery”;

NOTED THAT also, the “Nebrodi” Internal Area, following the call for the allocation of resources dedicated to fund, on an experimental basis by municipalities present in the internal territories, also in associated form, scholarships for “Municipal PhD Programmes” for the 38th cycle published by the Agency for the Territorial Cohesion with D.D.G. 196/2022 of 15th June 2022, expressed interest in the collaboration with the University of Messina, for the participation in the same PhD Programme, and therefore signed a collaboration Agreement, according to art. 15 of Law No. 241 of 7th August 1990;

IN VIEW OF the D.D.G. No. 288/2022 of 12th September 2022, with which the Agency for the Territorial Cohesion approved the list of the applications admitted to funding, among which there is the one proposed by the Municipality of Sant’Agata di Militello for the Nebrodi Internal Area, in collaboration with the University of Messina, admitted to funding for 3 years and an amount of € 75.000,00;

IN VIEW OF the resolutions of the Academic Senate and the Board of Directors, respectively, prot. no.121259 and no.121739 of 3rd October 2022, with which the publication of a Call for presentation of applications for assignment of no. 14 scholarships was authorized, expiring in 10 days from the publication, open to all the candidates eligible who are not already recipient of D.M. 351/2022 and D.M. 352/2022 scholarships in the competition for admission to the PhD Courses 38th cycle of the University of Messina, referred to in D.R. No.1741/2022, in order to assign the D.M. 351 and/or D.M. 352 positions available, by a selection based on the consistency evaluation of the projects presented by the candidates with regard to the obligatory topics referred to in D.M. No. 351 and No. 352 of 9th April 2022, carried out by the examination committees for admission to the PhD Courses expressly reconvened;

GIVEN THAT with the aforementioned resolutions, within the same Call, the presentation of applications open to the same subjects above, within the PhD Course in “Juridical Sciences”, for the selection of a candidate for the position with scholarship funded by the “Municipal PhD Programmes” Call 38th cycle, in obedience to the collaboration Agreement signed with the “Nebrodi” Internal Area and the objectives and expected results, indicated in the description of the proposal attached to the funded application, was authorized;

IN VIEW OF D.M. No. 247 of 23rd February 2022 with which, starting from 1st July 2022, the annual amount of the scholarship for the attendance of the PhD courses



was redetermined in € 16.243,00, gross of social security charges payable by the recipient;

WITH RESERVE any subsequent amendments and/or additions to the Call that will be advertised on the website of the University of Messina at the address <https://archivio.unime.it/it/ricerca/dottorati-ricerca/xxxviii-ciclo-bis/ammissione-38%C2%B0-ciclo-avviso-di-ricognizione>.

Please note that the Project Proposal on specific topics of the PhD course must be carried out by the candidate taking into consideration, **for the positions with an obligatory Project concerning the subject areas and topics indicated in the PNRR**, what is indicated in the Research Programme (for D.M. 351 Scholarships) or in the Training Project (for D.M. 352 Scholarships), as well as in the eligibility criteria established in art.7 of D.M. 351 and in art. 6 of D.M. 352 available at the following links:

For the position of the Municipal PhD Programme of Juridical Sciences, the Project Proposal must be carried out by the candidate taking into consideration what is indicated in the Project of the Municipal PhD Programme published at the link <https://archivio.unime.it/it/ricerca/dottorati-ricerca/xxxviii-ciclo-bis/ammissione-38%C2%B0-ciclo-avviso-di-ricognizione>.

The duration of the aforementioned PhD courses is three years.

Please note that the PhD positions under the resources of the PNRR can be activated and launched **only after the positive outcome of the eligibility and consistency verification of the research projects carried out by the MUR and the ANVUR, in relation to the scholarships selected** according to the eligibility requirements identified by the aforementioned Ministerial Decrees.

Any negative outcome of the aforementioned evaluation, which affect the assignment of the available positions, will be announced to the candidates by means of the publication on the institutional website. In this case, no claim can be laid by the candidates against the University of Messina.

After the positive outcomes of the aforementioned evaluations, the activities of the PhD courses funded according to the aforementioned ministerial decrees must be started by 31st December 2022.

Art. 2

Admission requirements

For the PhD courses indicated in art.1, candidates **eligible** (admitted and not admitted), who are **not already recipients of D.M. No.351/2022 and No.352/2022 scholarships**, in



the merit rankings within the selection procedure referred to in D.R. No. 1741 of 27th June 2022, can participate in this Call, obviously, exclusively for the PhD course for which they are in the ranking.

Admission requirements indicated in art.2 of the Call for selection referred to in D.R. No. 1741 of 27th June 2022 are left unprejudiced.

Art. 3 How to apply

Candidates **eligible** (admitted and not admitted) **who are not already recipients of scholarships according to D.M. No. 351/2022 and No. 352/2022** in the aforementioned merit rankings, holding the requirements referred to in art.2, **must** submit, electronically, through the Esse3 platform <https://unime.esse3.cineca.it/Home.do> (where they are already registered as participants in the Call for selection referred to in D.R. No.1741 of 27th June 2022) an application to participate in this Call, according to the form available at the link <https://archivio.unime.it/it/ricerca/dottorati-ricerca/xxxviii-ciclo-bis/ammissione-38%C2%B0-ciclo-avviso-di-ricognizione> and on the Esse3 platform, and the Project Proposal for every single position with scholarship they want to participate within the PhD course.

The submission of the application through the online procedure implies the acceptance by the candidates of the rules contained in this Call, in the current PhD course Regulation at the University of Messina, in the rules of the Call referred to in D.R. No. 1741 of 27th June 2022, including the attachments, in the Research Programmes (for D.M. 351), in the Training Projects (for D.M. 352) and in the Project of Municipal PhD Programme, indicated in art.1 of this Call, which are integral part of it, in the collaboration Agreement signed with the "Nebrodi" Internal Area relating to the Municipal PhD Programme and in all the mentioned rules.

The procedure for participation will be active **until 16th October 2022 at 11.59 p.m.** After this period, the connection will be deactivated, and it will no longer be possible to complete the application form. Applications received after the indicated deadline or produced and/or received in a different way, **will be excluded.**

For each scholarship with a specific obligatory Project under the resources of the PNRR, in art.1 of this Call it is indicated the link where the Research Programme (for D.M. 351) or the Training Project (for D.M. 352) to be observed by the candidate in the drafting of his/her own Project Proposal, in compliance with the eligibility criteria provided for by the aforementioned decrees, are published.

With regard to the Scholarship of the Municipal PhD Programme in Juridical Sciences, the Project to be observed by the candidate in the drafting of the Project Proposal is published at the link indicated in art.1.

Candidates do not have to pay any contribution for participation in this procedure.

Art. 4 PhD examination Committees

The Project proposals referred to in this Call will be evaluated by the examination Committees for admission to the PhD courses, following a specific reconvening.



Art. 5 Evaluation of the Project Proposal

The PhD examination Committee proceeds with the evaluation of the Project Proposal of the candidate, expressing in a private session a judgement of suitability and consistency in relation to the topics referred to in the PNRR (pursuant to D.M. 351/2022 and D.M. 352/2022) and to the Topic of the Municipal PhD Programme. For this purpose the Committees will have to verify:

- **for each Scholarship under the resources of the PNRR**, if the Project Proposal presented by the candidates takes into consideration what is indicated in the Research Programme (for D.M. 351 Scholarships) or in the Training Project (for D.M. 352 Scholarships), as well as in the eligibility criteria established in art. 7,8,9 of D.M. 351 or in art.6 of D.M. 352;
- **with regard to the Scholarship for the Municipal PhD Programme**, if the Project Proposal presented by the candidates is consistent and taking into account the Topic, the objectives and the expected results of the PhD course, indicated in the Project of the Municipal PhD Programme.

Candidates **are not allowed** to attend in this evaluation.

Committees must finalise work **by 19th October 2022**.

Art. 6 Admission to PhD courses

Candidates are admitted to PhD courses according to the ranking order and taking into account the suitability expressed by the PhD Committee for the individual obligatory Projects pursuant to D.M. 351/2022 and D.M. 352/2022, and for the obligatory Project of the Municipal PhD Programme.

Reference is made in full **to art.6** of the Call referred to in D.R. No. 1741 of 27th June 2022.

Art. 7 Enrollment Procedures

Candidates admitted to the PhD courses based on the final ranking must express their acceptance **within the peremptory deadline of 5 days from the publication** of the evaluation results on the website <https://archivio.unime.it/it/ricerca/dottorati-ricerca/xxxviii-ciclo-bis/ammissione-38%C2%B0-ciclo-avviso-di-ricognizione>. Failure to complete the enrollment will result in the forfeiture of admission to the PhD Course. **No personal communications will be sent to candidates. Candidates admitted to the PhD courses are responsible for checking the dates and enrollment procedures.**

Art. 8 Scrolling of ranking and taking over

In the event of forfeiture or waiver by admitted candidates, the final ranking will be scrolled down for positively evaluated candidates **only in obedience to procedures and deadlines provided for by MUR financing**, for Scholarships under the PNRR, and to procedures established by the Agency for the Territorial Cohesion for the Scholarship of the Municipal PhD Programme, as well as in compliance with the conditions established in art.8 of D.R. No. 1741 of 27th June 2022.

Art. 9 Taxes and fees

For contributory requirements for enrollment and registration to PhD Courses, reference is made to what is provided for by art.9 of the Call referred to in D.R. No. 1741 of 27th June 2022.

Art.10 Scholarships

The PhD scholarships have a total duration of at least three years and are annually renewed, following a positive verification by the PhD Academic Board about the completion of the program of the activities planned for the previous year, as provided for by art. 20 of the PhD Regulation of the University of Messina.

Starting from 1st July 2022, the annual amount of the scholarship for the attendance of the PhD courses is equal to 16.243,00, gross of social security charges payable by the recipient.

The conduct of activity research abroad, prior authorization of the PhD Academic Board, is regulated by the PhD Regulation of the University of Messina.

For the PhD positions under the resources of the PNRR, the mandatory period of study abroad is stated by D.M. No. 351/2022 and 352/2022, and it is reported in the related Research Programmes D.M. 351 or Research Projects D.M. 352.

The scholarship **cannot be combined** with any other scholarship, assigned for any purpose, except for those granted by Italian or foreign institutions useful for integrating the PhD student's training and research activity with stays abroad. The PhD scholarship is subject to the payment of social security contributions INPS "*Gestione Separata*" in accordance with current legislation, of which two-thirds shall be borne by the administration and one-third by the PhD student with a scholarship.

Art. 11 Rights and obligations of the PhD Student

PhD students must attend the courses and continuously carry out study and research activities under the approved individual programme, as provided for by art. 23 of the University Regulation.

For positions with **a specific obligatory Project**, concerning the subject areas and the topics referred to in the PNRR (according to D.M. 351/2022 and D.M. 352/2022), PhD students



must produce a report indicating the time commitment (divided into months spent at the company, on-site, abroad) and a summary of the activities carried out every six months. To verify and validate what is indicated by the PhD student will be the PhD course coordinator's responsibility.

For the position of the **Municipal PhD Programme**, PhD students must carry out the research activities in compliance with the indications and regulations of the Municipal PhD Programme.

Art. 12

Attendance, suspension, forfeiture, and waiver

For the regulation on attendance, suspension, forfeiture and waiver, reference is made to what is provided for by art.12 of the Call referred to in D.R. No. 1741 of 27th June 2022.

Art. 13

Processing of personal data

The processing of personal data related to this Call is carried out by the University in accordance with the European General Regulation No. 679/2016 for the protection of personal data and the Code regarding the protection of personal data, Legislative Decree No. 196/2003, and subsequent amendments and additions.
